Rules and Regulations of the Young Artists Competition

- 1. CANDIDATE MUST PERFORM WORK FROM MEMORY.**
- 2. CANDIDATE MUST PROVIDE THEIR OWN PIANO ACCOMPANIST. THIS IS A REQUIREMENT OF ALL APPLICANTS. PIANO WILL BE PROVIDED.**
3. Candidates must include 3 copies of the score (piano score is acceptable) with Application.
4. Selected work must be considered to be a standard work for solo instrument/voice and orchestra.
5. The Jury may select more than one winner; however, the Jury reserves the right not to select any winners.
6. Once the Application has been confirmed, the application fee will not be returned if the candidate cancels his / her appearance in the Competition or fails to appear.
7. All candidates must include a \$35 application fee with the Application.
8. Travel and hotel expenses are the responsibility of the candidate.
9. Application implies acceptance of the Competition rules and regulations.
10. The Jury reserves the right to refuse a candidate or to exclude a candidate without obligation to justify its decision. The decision of the Jury is final. The Southeastern Pennsylvania Symphony reserves the right to cancel the Competition for any reason. If the Competition is cancelled, the Symphony will refund application fee and the candidate shall have no further legal recourse against the Southeastern Pennsylvania Symphony.
11. First place winner(s) will perform as a soloist with the Southeastern Pennsylvania Symphony Orchestra during the 2019-2020 Season.
12. Competition is open to all young artists born after April 13, 2001 and who reside in Montgomery, Bucks, Philadelphia, Delaware, Lehigh, Chester, or Northampton Counties.
13. Former 1st place winners are not eligible to compete in this Competition again.
14. Winner(s) selected to perform with the Southeastern Pennsylvania Symphony Orchestra must participate in any and all interviews and public appearances, and must provide the Southeastern Pennsylvania Symphony Orchestra with any requested biography and photograph.
